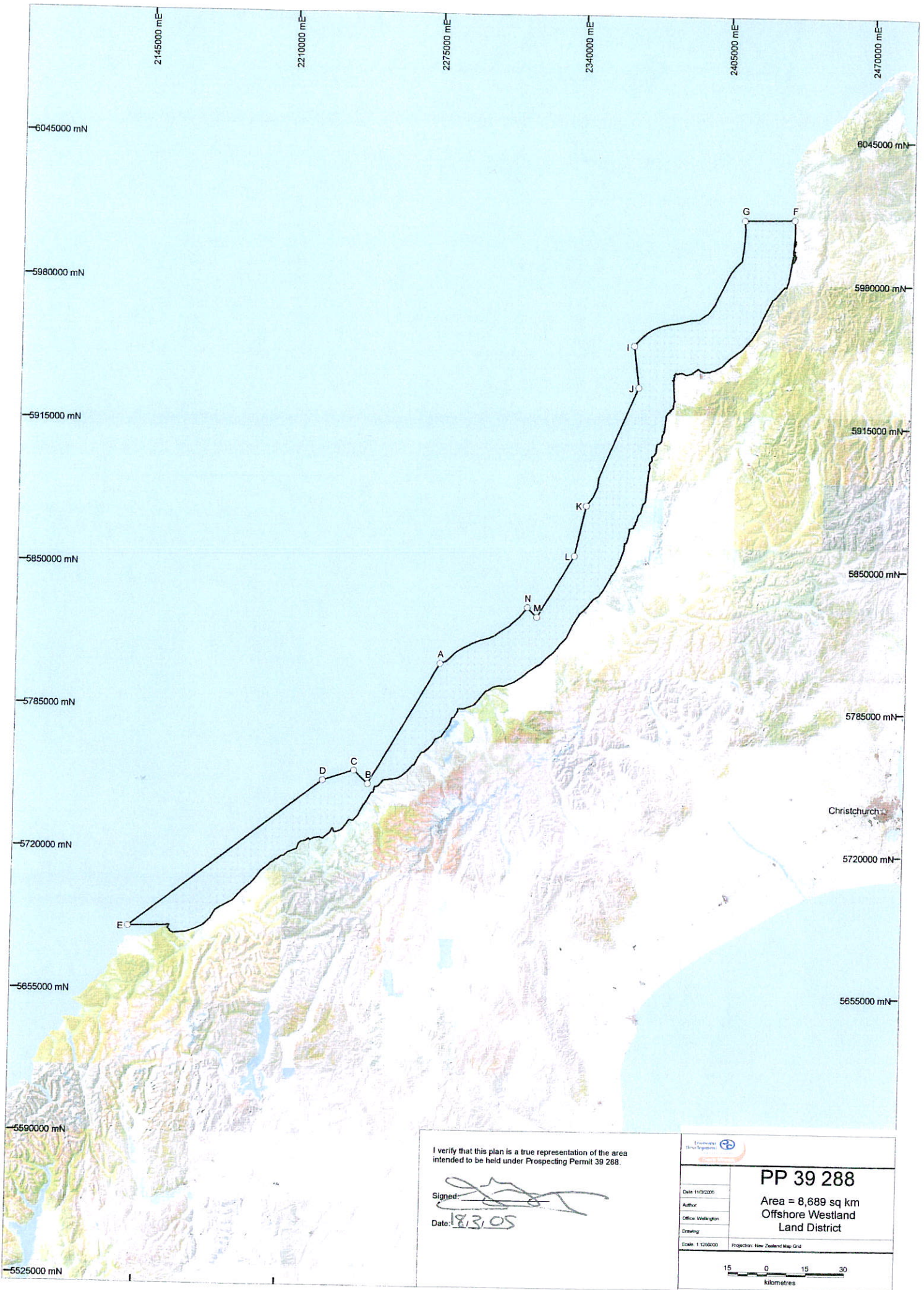
LEGAL DESCRIPTION OF PERMIT AREA:


